The Board of a company is the governing body of a company which is responsible for taking all decisions in respect of operations of the Company based on the Articles of Association of the Company and the Companies Act, 2013 and other applicable laws. A board resolution for resignation of directors of a company takes on record resignations submitted by director (s) of a Company to the Board and authorises a designated person to make filings with the Registrar of Companies in respect of the same.
