Private Patrol Operator. The Private Security Services Act requires a private patrol operator (PPO) to obtain a general liability insurance policy with a minimum coverage of one million dollars (\$1,000,000) for each occurrence for initial licensure, and to have the required insurance in effect at the time of license renewal and for the continued maintenance of the license.
